The above "Effective Rate for 2007" is used to compute Real Estate Taxes for the tax year 2007, payable in 2008. The "Total Rate 2007" is used to compute Personal Property Taxes to be filed and paid in 2008. Your Real Estate gross tax is computed by multiplying the tax value of your property by the effective rate for either Agriculture / Residential or Other, which is either Commercial or Industrial. The total rate is a combination of rates set as a result of elections in your district for County, Schools, Townships and Corporations.
